# Attention to Details for Residents

- ❖ Include family and friends when requested
- ❖ Appropriate translation and counseling
- ❖ Emergency contact
- ❖ Special consideration to residents with special needs
- ❖ Assist in the locating the relocation unit
- ❖ Provide all necessary support and assistance around the move process including arranging for the move



# Relocation Process

- ❖ All residents previously received the General Information Notice (GIN) in 2023.
- ❖ HTH Relocation Manager on-site beginning January 2024.
- ❖ HTH will begin meeting one-on-one with each household beginning of 2024. During this process HTH will conduct individual assessments with each household to explain the redevelopment plan, relocation process and collect information about your household.
- ❖ 90 Day Notice/Notice of Eligibility
- ❖ HTH assistance with locating and securing a new home
  - Transfer to another RHA unit, Section 8 voucher
- ❖ Disconnect/reconnect of services



# Relocation Assistance & Benefits

## ❖ Relocation Advisory Services and Counseling

- HTH's team will meet with you to explain the redevelopment and relocation plan and conduct an assessment to understand your household needs and preferences for your move.

## ❖ Notifications

- You will receive at least 90 Days Written Notice. This notice will have at least one comparable relocation unit
- Written, phone, in-person updates by HTH's team in the time leading up to your move.



# Relocation Assistance & Benefits

- ❖ Moving Assistance (One of Two Options)
  - Option 1: HTH coordinates your move with a professional, licensed and bonded moving company. You do not incur any out of pocket expenses due to this move.
  - Option 2: You take on moving yourself to your relocation unit and after you have returned your keys and HTH has inspected your unit then you receive a lump sum payment based on how many bedrooms you lived in.
  
- ❖ Support and Guidance through the relocation process
  - HTH is here to assist you through each step of the relocation process and will be your first point of contact regarding relocation questions or concerns. You are welcome to include any family, friends or others in this process.
