HOLD HARMLESS AGREEMENT FOR

TRANSPORTATION OF MINOR

Description of Activity:

Transporting a minor resident of the Housing Authority of the City of Reno (RHA) owned Public Housing complex in an RHA owned/insured vehicle by an RHA staff member to RHA sponsored activities during the period:

Please read this form carefully and be aware in signing this waiver for your minor child/ward to be transported by RHA owned/insured vehicle by an RHA staff member and any activities associated therewith, you will be waiving your rights to all claims for injuries you and/or your minor child/ward might sustain arising out of being transported by RHA owned/insured vehicle by an RHA staff member and you will be required to indemnify, hold harmless and defend the Housing Authority of the City of Reno (RHA) for any claims arising out of your minor child/ward being transported by RHA owned/insured vehicle by an RHA staff member.

In consideration of my minor child/ward being allowed to be transported by automobile by an RHA staff member, as the Parent or Legal Guardian of a minor child residing in an RHA owned property, under the age of 18 years of age, I recognize and acknowledge that there are certain risks of physical injury associated with being transported by RHA vehicle by RHA staff member. I agree to assume the full risk of injuries that may be sustained by any minor child/ward of mine, as a result of being transported by RHA vehicle by RHA staff member and all activities connected or associated therewith. I agree to waive and relinquish all claims on behalf of my minor child/ward that the minor child/ward may have against RHA as a result of the minor child being transported by RHA vehicle by RHA staff.

I do hereby fully release and discharge the Housing Authority of the City of Reno and its officers, agents and employees from any and all claims from injuries, damage or loss which I, or any minor child/ward may have or which may occur on account of his/her being transported by RHA vehicle by RHA staff member. I further agree to indemnify and hold harmless and defend the Housing Authority of the City of Reno, its officers, agents and employees from any and all claims sustained by me or my minor child/ward, and arising out of, connected with, or in any way associated with being transported by RHA vehicle by RHA staff member.

The invalidity or unenforceability of any of the provisions hereof shall not affect the validity or enforceability of the remainder of this Agreement.
